Accident Investigation

Do you know the true cost of an accident? This workshop will provide Management, Supervisors and Safety Committee Members and Representatives with the information they require to develop an effective incident investigation policy and procedures. A practical investigation element outlining legal obligations will be included with the focus on developing effective recommendations to prevent a reoccurrence.

Confined Space Entry

Confined spaces present life threatening hazards in construction. This workshop is for anyone who conducts or supervises work in confined spaces. Course elements will include: hazard recognition, crew training requirements, atmospheric testing and ventilation methods, respiratory and rescue means, entry permits, hot work procedures and lockouts. The workshop includes an interactive practical demonstration of proper work procedures utilizing required breathing apparatus and rescue equipment.

Emergency Spill Response

This workshop will provide information and answer questions with respect to liability issues of key Management personnel within an organization.

Fall Protection

Zero Tolerance for lack of fall protection! Are you at risk? In Manitoba, regulatory requirements for fall protection apply to ALL workers at risk of falling 8' or further. Horizontal and vertical fall arrest systems, guardrail alternatives and CSA Standards will be discussed.

Hazards of Mould in Buildings

Prime Contractor Responsibilities

Workplace Safety & Health (WSH Division) Legislation requires a Prime Contractor to be designated on all construction projects where more than one employer or self-employed person(s) are involved in work on the site at the same time. This course will examine a Prime Contractor's legislated requirements and focus on developing practical methods to meet these requirements.

Scaffolding Awareness

Fatal or disabling injuries may result from workers falling from scaffolds used in construction, demolition, and plant maintenance. Workplace Safety requirements and the importance of written safe work practices and procedures will also be discussed.
